◆ Category: Second Industrial Age

◆ Topic: Urban Growth

♦ Grade Level: 11

 Prerequisites: Students should have an understanding of the social and economic fabric of the United States before the Civil War.

Activity Overview

Students will choose one of the cities listed on their student data sheets to research, using the sources listed on their data sheets. After gathering information about urbanization and immigration in the late 19th and early 20th centuries for their designated city, students will assemble in groups composed of experts on each of eight U.S. cities to organize and analyze their research using the ImCit CellSheetTM App. After collaboratively analyzing the trends and patterns of urbanization and immigration in these cities from 1870 to 1920, students will review their findings in a whole class debriefing discussion.

Tip

Allowing students to choose which city they are most interested in researching will increase their interest level in the activity. However, based on the number of students in your class, tally how many city "slots" are available to be chosen so that base groups will be composed of one expert on each of the eight cities to be analyzed in the spreadsheet. Depending on class size, some groups may contain more than one expert on a given city.

Directions

Before the Activity Begins

Be sure each student has a TI-83 Plus that is loaded with the CellSheet™ Application. Send the **ImCit** AppVar to the students using TI-Navigator™, the TI-GRAPH LINK™ Cable, or USB Cable.

Place students in groups of eight, then pass out the Student Data Sheet.

During the Activity

Record student city assignments and groups. Monitor student progress as they analyze the figures and information in the **ImCit** CellSheet[™] AppVar, answering any questions necessary to facilitate their discussion of the questions on the Student Data Sheet.

Allow students who are researching the same cities to work together in order to share and verify their findings, if necessary.

Monitor group discussions, ensuring that all eight cities are reported on and discussed as the group completes and analyzes the **ImCit** CellSheet™ AppVar, and answers the debriefing discussion questions on the Student Data Sheet.

After the Activity

Lead a class discussion that covers the debriefing questions the students answered on their Student Data Sheet.

One of the best ways to study population trends as America's history evolves is to look at the growth of major U.S. cities from the Early National Period up to the period just after the Stock Market Crash of 1929. You will be researching information describing and analyzing the rise of industrial America, including the growth of cities and the influence and impact of immigration. Use the sources listed below to locate the following information on your chosen city and on the populations of the top ten cities in the U.S. from 1870 to 1930.

- ◆ Population of New York City by the decade: 1800 to 1930
- ♦ Population of Philadelphia, PA by the decade: 1800 to 1930
- ♦ Population of Baltimore, MD by the decade: 1800 to 1930
- ♦ Population of Boston, MA by the decade: 1800 to 1930
- ♦ Population of Cincinnati, OH by the decade: 1800 to 1930
- ♦ Population of St. Louis, MO by the decade: 1800 to 1930
- ♦ Population of Chicago, IL. by the decade: 1800 to 1930
- ♦ Population of Charleston, SC by the decade: 1800 to 1930
- ◆ Populations of the top ten cities in the U.S. in the decades beginning after the Civil War and ending after the Stock Market Crash of 1929

After researching the cities, be prepared to answer the following questions:

- 1. What kind of information were you able to get from your primary source(s)?
- 2. Is the primary source information accurate? Justify your answer.
- 3. How can this information be cross-referenced?
- 4. Why do you think the statistics are presented in 10-year intervals as opposed to random years?

Recording the Information

Assemble in groups. Each group should have at least one researcher from each of the eight cities researched to analyze the information on your assigned city in the **ImCit** CellSheetTM AppVar using the following procedure.

- 1. What would you need to do to find the average population change for each of the cities on your spreadsheet between the years 1860 and 1930?
- 2. Why would you want to know the average population change for these years? What kinds of inferences can be made about a city with a significant percentage of change?
- 3. Record below the average percentage of change for each city on the spreadsheet.

Analyzing the Information Further

Using the information in the **ImCit** AppVar, answer the following questions:

- 1. What cities experienced the highest rate of population growth between 1800 and 1930?
- 2. Which year had the highest rate of population growth?
- 3. Which city had the highest rate of population growth before the Civil War?
- 4. Which city had the highest rate of population growth after the Civil War?
- 5. By the turn of the century, which city had grown the most in its population?
- 6. Why do you think Chicago grew faster than Baltimore?
- 7. What generalizations can you make about the growth of United States cities in the second half of the nineteenth century?

8. What factors should be taken into consideration when analyzing the reasons for the rapid growth between 1880 and 1910?

9. Which geographic regions of the United States saw a significant increase in population between 1900 and 1930? Discuss what the reasons may have been for this increase.

10. Is there a city that enjoyed top ten status prior to the Civil War that lost its position and never regained it? Name the city and provide reasons that helped to bring about its decline.

11. Which region of the U.S. saw the most growth overall? Discuss the various possibilities as to why this occurred.


Instructions for Using the TI-83 Plus


Transferring the ImCit CellSheet™ AppVar from the Teacher's TI-83 Plus

- 1. Connect the devices using the unit-to-unit cable. Press the cable firmly into the port at the base of each device.
- 2. Prepare the student's device to receive data.
 - a. Turn the device on.
 - b. Press 2nd X,T,O,n to prepare the TI-83 Plus to receive data.
 - c. Highlight **RECEIVE** by pressing **.**

- d. Press ENTER. **Waiting**... is displayed on the device.
- 3. Prepare the teacher's device to send data.
 - a. Turn the device on.
 - b. Press 2nd (X,T,Θ,n) to prepare the device for linking.
 - c. Press ▲ or ▼ until **D:AppVars**... is highlighted.












- d. Press ENTER to view the AppVars. Move the cursor to **ImCit**.
- e. Press ENTER. Press to highlight TRANSMIT. Press ENTER to start data transfer.




Download the AppVar to other students using the same method. Substitute your device for the teacher's device when using these instructions.

Accessing the ImCit CellSheet™ AppVar

- 1. Open the **CellSheet** App.
 - a. Press APPS, then press ▲ ▼ to highlight CelSheet. Press ENTER to begin the CellSheet™ Application.



b. Press ENTER (or any key) to move past the information screen.



c. Press ENTER (or any key) to move past the **CelSheet** Help screen.



d. If the **ImCit** spreadsheet does not appear in the window, press GRAPH to display the CellSheet Menu.



e. Press 1 or ENTER if 1:File is highlighted.





g. Press ENTER when the arrow points to ImCit. You should now have the same screen as the one that appears to the right.

Calculating Average Percent of Change in the CellSheet™ Application

- Within the spreadsheet (in this case, ImCit), go to any column labeled "Percent Change." This example will calculate the average percentage of change for the city of Baltimore, in Column C.
 - a. First, look at the range of cells in Column C containing percentage values. In this case cells C3 C15 contain values. Therefore, you will want to type in a formula for calculating the average, or mean, value of cells C3 C15 in cell C16. Use ▼ to reach the end of that range, in this case, cell C 16. Press ENTER when the cursor gets to C16, so that you can see the cursor blinking in the edit line:
 - b. Now that the cursor is blinking in the edit line, press STO+ to get an equal sign in front of the formula. This signals the application that it will need to calculate a formula.
 - c. Press GRAPH to display the FUNCTIONS menu. Press either 2 or move the cursor to 2: mean(.

Press ENTER. The display should look like the example at the right.

d. Type in the range of cells you would like to average, in this case C3 to C15. To do this, press 2nd PRGM to type C, and then press the 3. Press ALPHA (decimal key) to enter a colon. Press 2nd PRGM again to get C, followed by 15. Close the parentheses by pressing). Your screen should look like the example at the right.
